The following information refers to the Requirements Table

(*1) Both **Reiki Practitioner** and **Reiki Master/Teacher** categories require insurance coverage. If you do not already hold *Public Liability & Professional Indemnity Insurance*, you will need to complete your membership application and receive your Reiki Australia membership number before applying for insurance. Insurance is available to Australian residents only.

(*2) One of the requirements of the National Code of Conduct for Health Care Workers is that a healthcare practitioner must be able to provide their clients with immediate first aid if an adverse event were to occur. *Nurses and paramedics with current registration may be exempt from this category requirement by providing relevant documentation.*

(*3) **Reiki Practitioner** member category requires you to provide a log of 10 Reiki treatment sessions over your **first year** of membership. Due to privacy and confidentiality, no identifying details of clients are required on the treatment log.
